Important Note: -

1. The above shortlisted candidates have to appear for Personal Interview.
2. This may be treated as INTIMATION to all shortlisted candidates. However, call letters for Personal Interview will be sent separately in due course.
3. Those candidates who are in Govt. Service (including AIIMS Employees) are required to produce No Objection Certificate (NOC) at the time of Interview. No candidates will be allowed to appear for the Interview without NOC as per the conditions of the advertisement.
4. Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non- creamy layer) in the prescribed form issued by Competent Authority. The certificate should be of the current financial year, in accordance with instructions issued by the Government of India in this respect from time to time. Applicants should ascertain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes.
5. The candidature of all the candidates for Personal Interview is purely provisional subject to verification and fulfilment of the eligibility criteria with regards to age, essential qualification, experience and reservation etc. and if they are found ineligible at any stage, their candidature will be cancelled.
6. The above list is purely tentative and may vary (both inclusion/exclusion) subsequently after detailed examination/verification. The decision of the Competent Authority in this regard will be final.
7. In case vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancies shall not be carried forward to the next recruitment year as backlog and in this scenario, the EWS post will be filled up as UR Category post.
