Shortlisted candidates based on their CV shall be called for an interview and discussion of eligible candidates on 28.06.2022, Tuesday, at 10.00 AM in Department of Microbiology, 4<sup>th</sup> Floor, Medical College Block (Academic Block – 1), at AIIMS Kalyani. The candidate should come with all original documents along with one photocopy set and valid photo ID at the time of interview.

\* If any suitable candidate is unavailable from Medical / Dentistry / Veterinary background, then the post shall be offered to the best in merit Non-Medical applicant, qualifying the criteria for Scientist B (Non-Medical) attached in Appendix – 2. Non-medical candidates shall be shortlisted only in case sufficient number of suitable candidates from Medical / Dentistry / Veterinary background is unavailable.

In case number of applicants are higher than three times of the advertised posts, the applicants will be short listed for interview based on the screening criteria mention in the appendix 1 & 2.

### **RESEARCH SCIENTIST (B) (MEDICAL)**

#### **Essential Qualifications:**

MBBS with registration recognized by MCI

Or

BDS (Dentistry) / B. V. Sc (Veterinary Sciences) degree with registration recognized by DCI / VCI with one year experience

#### **Desirable Qualifications:**

- i. MD / MDS / M.V.Sc in a related subject to viral / microbial / genetics research from a recognized university
- ii. PhD in a related subject from a recognized institute
- iii. Additional Postdoctoral research / training experience in relevant subjects in recognized institute(s)
- iv. Preference will be given to candidates having experience in virology / molecular diagnostics related laboratory work, NABL accreditation, and knowledge of computer applications.
- v. Two years Research experience in relevant subject after obtaining essential qualification.
- vi. Higher qualification & experience more than the essential qualification in the relevant discipline will be an advantage for shortlisting.

#### **Notes :**

- i. MD / MDS / M.V.Sc degree in relevant subjects shall be treated equivalent to three years' experience.
- ii. Candidates without any demonstrable hands on experience in microbiology, virology and molecular diagnostics should NOT apply.

## **Appendix-2 :-**

### **RESEARCH SCIENTIST B (NON - MEDICAL)**

#### **Essential Qualifications:**

Master's degree and Ph.D in relevant subject from a recognized university

#### **Desirable Qualifications:**

- i. Candidates with completed PhD will have benefit over candidates without PhD or candidates submitted thesis but PhD not yet awarded.
- ii. Preference will be given to candidates having experience in virology / molecular diagnostics / genetics related laboratory work, NABL accreditation process, authorship in peer reviewed indexed publications, and knowledge of computer applications.
- iii. Two years Research experience in relevant subject after obtaining essential qualification.
- iv. Higher qualification & experience more than the essential qualification in the relevant discipline will be an advantage for shortlisting.

#### **Notes :**

- i. PhD degree in relevant subjects shall be treated equivalent to three years' experience.
- ii. Candidates WITHOUT any demonstrable hands-on experience in microbiology, virology, molecular diagnostics or biotechnology should NOT apply.

## **INSTRUCTIONS TO CANDIDATES**

1. Age limit of the candidates less than 45 years on the day of notification released.
2. Upper age limit may be relaxed /altered at the discretion of the authority in case of exceptionally suitable candidates.
3. The post will be **Purely Contractual** and shall be renewed every six months based on performance. In case the termination of contract is before the completion of 6 months, one month notice period shall have to be served by either party – employee or employer.
4. Posts will not be considered as permanent at any point of time.
5. No TA/DA will be provided for attending the interview.
6. Pension GPF/PF/Leave benefits will not be applicable as permanent posts. Notification for leaves on each calendar year shall be provided at joining.
7. Submission of wrong or false information during the process of selection shall disqualify the candidate at any stage & may lead to criminal prosecution.
8. Candidate reporting after 11.00 am on the interview date will not be permitted for registration, document verification and walk-Interview.
9. Any form of canvassing will lead to disqualification of candidate.
10. Candidates are requested to bring the following certificates in original and a self-attested copy of each at the time of interview.
  - Proof of age (SSC certificate/class 10 or Matriculation certificate, admit card)
  - Certificate of academic qualification
  - Work and Research experience Certificate

All the applicants are expected to work in virology research and diagnostic laboratory and shall mandatorily require to be vaccinated against vaccine preventable viral illnesses to protect themselves, their family and their colleagues. Time to time vaccination drives shall be carried out in the department for the laboratory staffs.
