2. Point no. 7 of Special Terms and Conditions at Page 18 of the Tender Document
“AIIMS Kalyani will have its discretionary power to give any refreshment order to any of the empanelled bidders based on the internal feedback and discussion. That will be binding upon all the empanelled bidders.”
3. Point no. 5 in E group of Qualification Criteria at Page no. 6 of the Tender Document:
“In case of Company’s authorised channel partner / Franchisee participating on the behalf of company, a valid agreement with the parent company will be required”
