- 1. Period of supply: Supply terms mentioned in the Purchase Order should be strictly adhered to.

- 3. **Rate:** Rates should be quoted in Indian Rupees (INR) on F.O.R Basis at AIIMS, Kalyani, West Bengal, Inclusive of all the Charges, with break-ups:
  - Basic Cost.
  - GST as applicable.
  - Total Cost (F.O.R at Central Stores, AIIMS Kalyani).
- 4. **Validity:** The quoted rates must be valid for a period for 180 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If
